#### Welcome to the ICN NP/APN Network Conference Call for Abstracts!

The ICN NP/APN Network Conference is the premier international gathering for advanced practice nursing leaders, educators, researchers, and practitioners. This event fosters global collaboration and knowledge-sharing to advance the role of advanced practice nursing worldwide. We invite abstracts that showcase innovation, evidence-based practice, policy advancements, and leadership strategies that contribute to the growth and impact of advanced practice nursing. Selected abstracts will be featured in oral presentations and poster sessions at the conference. The Abstract Submission Portal will open June 16, 2025, at 12:01am CT/USA. Abstracts must be non-commercial and submitted by October 15, 2025, at 11:59pm CT/USA.

## **Eligibility Criteria**

- Abstracts must be submitted by nurses, healthcare professionals, educators, or researchers with expertise in advanced practice nursing.
- Submissions from individuals representing diverse perspectives, including interdisciplinary and international collaborations, are highly encouraged.
- Accepted presenters must register for the conference before February 2, 2026. Accepted
  abstracts will be eliminated from the program after this date if registration and fee payment
  have not been received.
- Accepted presenters must be available to present in person.
- Primary author must be a member of an ICN member organization. A person who is not a
  member of an ICN member organization may only submit as a co-author. To review ICN

## **Key Abstract Elements**

A strong abstract should include the following elements. Please note that while this structure provides a general guideline, flexibility is allowed—particularly for submissions presenting clinical practice overviews, quality improvement initiatives, or data-driven projects. Authors are encouraged to adapt the format as needed to best represent their work.

## 1. Problem & Purpose

- Clearly define the issue addressed and its relevance to advanced practice nursing.
- Explain the significance of the topic and the need for action.

#### 2. Background & Evidence

- Provide context through data analysis, research findings, or literature reviews.
- Identify gaps or opportunities that led to the project or study.

## 3. Methods & Approach

- Describe the methodology or strategy implemented.
- Highlight innovative approaches, frameworks, or interventions.

## 4. Outcomes & Impact

- Present measurable results, including qualitative and/or quantitative outcomes.
- Discuss the implications for practice, education, leadership, or policy.

#### 5. Innovation & Future Directions

- Outline novel aspects of the work.
- Suggest potential applications or next steps.

- No Preference The review committee will determine the best format for your abstract.

#### **Submission Guidelines**

- 1. **Title** Create a concise and engaging title (maximum 12 words).
- 2. **Abstract Body** Limited to 2000 characters (with spaces) Research focused abstracts should include: Problem, Background, Methods, Outcomes, and Conclusion.
- 3. Learning Objectives Include at least one clear and measurable learning objective.
- 4. **References** Provide relevant references, using a consistent format.
- 5. **Presenter Information** List all authors and affiliations. The primary presenter will be the main contact person. You may list up to two authors total: a primary author is required, and a co-author is optional.
- 6. **Speaker Expertise** Briefly describe your experience as a speaker. If you are new to public speaking, that is completely acceptable—this conference values and encourages the participation of emerging presenters.













#### **Submission Process**

- Abstracts must be submitted through the CVENT conference abstract submission portal.
- Formatting: Plain text only (no tables or images).
- Deadline: October 1, 2025, at 11:59 PM (CT/USA).
- Notifications: Accepted abstracts will be announced before January 15, 2026.

#### **Review & Selection Criteria**

Abstracts will be evaluated based on:

- Relevance to advanced practice nursing and global impact.
- Innovation and originality.
- Scientific rigor and clarity.
- Measurable outcomes and significance.

## **Final Tips for a Strong Submission**

- Write clearly and concisely, ensuring the abstract tells a compelling story.
- Use active voice and avoid jargon.
- Emphasize how your work advances the field of advanced practice nursing.
- Proofread carefully before submission.
- Use if artificial intelligence (AI) is acceptable for grammar, proofing, and spelling functions.
   Please do not use AI to generate your abstract entirely. Exercise sound judgement in the use of AI, knowing that you are the author of the content produced and responsible for its accuracy.
